Il concorso B Internazionale è regolato dal Blue Book 2022 e si svolgerà a Rossano Veneto (VI) presso "Villa Caffo Navarrini"

Il concorso è affiliato E.C.A.H.O. ed è disciplinato dai regolamenti EAHSC cui si rimanda. Il Comitato Organizzatore si riserva il diritto di apportare modifiche al programma ed in genere a quanto esposto nelle informazioni, in qualsiasi momento lo ritenga opportuno per la buona riuscita della manifestazione.

Le classi con più di 10 cavalli iscritti potranno essere divise, classi con meno di 3 cavalli iscritti potranno essere unite, a discrezione del comitato organizzatore.

International B show is regulated by the Blue Book 2022, and will take in Rossano Veneto (VI) at " Villa Caffo Navarrini". The B show is an ECAHO affiliated SHOW and it is under EAHSC rules. The organizing committee reserves the right to modify the present programme for the good success of the show. No class may be split unless there are more than 10 horses entered. Combination of a class with the next age group of the same sex is permitted if the number of entries for the class is below three.

The number of the pectoris will be attributed according to the date of birth of the horse, following an increasing criterion (from the smallest to the biggest).

## **CONDIZIONI DI PARTECIPAZIONE - CONDITION OF ENTRY**

Possono partecipare i cavalli che alla data di chiusura delle iscrizioni siano registrati in uno stud book riconosciuto dalla WAHO; Nessun cavallo sarà autorizzato ad entrare nel ring se il suo nome ed i suoi dati anagrafici non saranno stampati sul catalogo ufficiale del concorso. Tutti i cavalli iscritti al concorso dovranno essere in possesso di regolare PASSAPORTO EQUINO, comprendente un grafico descrittivo convalidato dall'autorità competente, rilasciato dal competente Registry (direttive CEE). Tutti i cavalli che accedono all'interno del quartiere fieristico dovranno essere muniti di polizza assicurativa a Rischio e Contro Terzi. Il responsabile del cavallo è il proprietario registrato o il locatario, ma la persona che firma il modulo di iscrizione, il conduttore e altro personale di supporto, inclusi ma non limitati a sposi e veterinari, potrà essere considerato responsabile in aggiunta se presenti all'evento o hanno preso una decisione pertinente sul cavallo. Se la persona responsabile designa qualcuno che li rappresenti (ad esempio un avvocato), qualsiasi corrispondenza inviata a questo rappresentante sarà ritenuta essere stata comunicata alla persona responsabile.

Il numero massimo di cavalli giudicato non deve superare 100 al giorno.

Nessun cavallo di età inferiore a 6 mesi può essere esibito senza la madre.

Nessuna fattrice gravida potrà essere esibita se gravida da più di 40 settimane dopo l'ultima data di copertura. Si consiglia di portare in show un certificato di intervento fecondativo valido (CIF). (Il conduttore deve produrre un CERTIFICATO DI FECONDAZIONE (CIF) valido al momento della richiesta della DC. La DC od i Giudici possono chiedere ad un veterinario un esame rettale. )

Open to horses that are registered in any WAHO recognized studbook by the closing date of entries. No horse will be permitted to enter the show ring unless its name and all other relevant details have been printed in the catalogue. An equine passport including a validated graphic description of the horse is mandatory for all international shows in European Union member countries (EEC directives). Each horse entering the fairground must be covered by proper insurance for damages caused. The person responsible for the horse is the registered owner or the lessee, but the person who signs the entry form, the handler, and other support personnel including but not limited to grooms and veterinarians may be regarded as additional persons responsible if they are present at the event or have made a relevant decision about the horse. Should the person responsible designate someone to represent them (e.g. a lawyer) any correspondence sent to this representative will be deemed to have been communicated to the person responsible.

The maximum number of horses judged must not exceed 100 per day.

No horse under 6 months of age may be exhibited without its mother.

No pregnant mare will be shown if she has been pregnant for more than 40 weeks after the last cover date.

It is advisable to bring a valid fertilization intervention certificate (CIF) to the show. (The handler must produce a CERTIFICATE OF FERTILIZATION (CIF) valid at the time of the DC's request. The DC or the Judges may ask a veterinarian for a rectal examination.)

### **RESTRINZIONE ALLA PARTECIPAZIONE - ENTRY RESTRICTIONS**

I vincitori di medaglia d'oro e d'argento in a Title show e in uno show di classe A non sono autorizzati a prendere parte a uno spettacolo B internazionale per i due anni consecutivi alla vincita, a meno che il cavallo non sia passato da yearling a junior, da junior a senior.

- I vincitori di una medaglia d'oro in due internazionali B dello stesso anno non possono prendere parte a una manifestazione internazionale B per il resto dell'anno solare.
- I castroni che hanno vinto medaglie d'oro o d'argento campioni a uno spettacolo per il titolo o uno spettacolo A non possono essere mostrati agli spettacoli B per il resto di quell'anno solare e un anno solare successivo.
- Chiunque iscriva un cavallo troppo qualificato sarà passibile di una multa di € 600 e il cavallo sarà squalificato.
  
- Title Show or A Show Champion Gold and Silver medal winners are not allowed to take part in a B International show for the rest of that calendar year and the two calendar years following, unless the horse has passed from a yearling to junior, from junior to a senior category.
- Gold medal winners in two B international Shows in the same year are not allowed to take part in a B International Show for the rest of that calendar year.
- Geldings that have won Champion Gold or Silver medals at a Title Show or an A show cannot be shown at B shows for the rest of that calendar year and one calendar year following.
- Anybody entering an overqualified horse will be liable to a fine of €600 and the horse will be disqualified.

### **METODO DI GIUDIZIO DELLE CATEGORIE - METHOD OF JUDGING THE CLASSES**

Ogni categoria sarà giudicata da 4 giudici indipendenti e senza catalogo che assegneranno un punteggio da 0 a 20 punti per: tipo, testa e collo, corpo, arti, movimento, con il mezzo punto.

Each category will be judged by 4 independent and without catalog judges who will assign a maximum of 20 points for type, head and neck, body, legs, movement, with the half point.

### **METODO E REGOLE PER QUALIFICA AL CAMPIONATO**

Entreranno nei campionati finali i Cavalli qualificati tra i primi 3 classificati di ogni categoria. Per ogni Campionato finale, saranno premiati solo i vincitori delle tre medaglie: Oro, Argento e Bronzo.

### **NUMBERS OF HORSES QUALIFIED TO THE CHAMPIONSHIP**

Horses qualified among the first 3 classified in each category will enter the final championships. For each final championship, only the winners of the three medals will be awarded: Gold, Silver and Bronze.

## REGOLA IN CASO DI SPAREGGIO - RULE FOR TIES

In caso di parità nei primi 5 classificati, il piazzamento migliore sarà assegnato al cavallo con più punti in tipicità. Se sussisterà ancora parità il piazzamento migliore sarà assegnato al cavallo con più punti in movimento. Se sussisterà ancora parità un giudice a sorteggio indicherà la sua preferenza.

The higher place will be given to the horse with the most points for type. If there is still a tie, the higher place will be given to the horse with the most points in movement. Failing a decision on either of these, one judge chosen by ballot will name his preference.

## METODO ECAHO CAMPIONATO APERTO

I vincitori delle Gold, Silver e Bronze Medal saranno scelti tra tutti i cavalli che si sono qualificati nelle rispettive classi. L'elenco degli iscritti ad ogni Campionato verrà comunicato dalla segreteria al termine delle categorie preliminari. Il Campionato verrà giudicato come segue:

Tutti i cavalli qualificati entreranno nel ring secondo il numero di pettorale del catalogo. I cavalli verranno giudicati individualmente, sia in standing che al trotto. Ogni giudice esprimerà in una sola volta la propria scelta per le medaglie Gold, Silver e Bronze scegliendo fra tutti cavalli qualificati per il campionato.

Ogni cavallo nominato riceverà i seguenti punti:

- Un cavallo nominato da un giudice per la medaglia d'oro riceverà 4 punti
- Un cavallo nominato da un giudice per medaglia d'argento riceverà 2 punti
- Un cavallo nominato da un giudice per la medaglia di bronzo riceverà 1 punto.

**La medaglia d'oro verrà assegnata al cavallo con il maggior numero di voti per la medaglia d'oro.**

In caso di parità di voti per la medaglia d'oro, la medaglia d'oro verrà assegnata al cavallo con il maggior numero di punti per i campionati.

Dagli altri cavalli: la medaglia d'argento sarà assegnata al cavallo con il maggior numero di punti di campionato.

La medaglia di bronzo verrà assegnata al cavallo con il 2° più alto numero di punti di campionato.

In caso di parità, saranno seguite le regole per gli spareggi nei campionati.

Sarà selezionato anche un quarto cavallo, che diventerà il vincitore della medaglia di bronzo se uno dei tre vincitori delle medaglie dovesse essere squalificato. Il nome di questo cavallo non sarà annunciato.

Nel caso in cui due o più vincitori di medaglie fossero squalificati, non sarà effettuata nessuna ulteriore sostituzione. Le preferenze dei 4 giudici saranno annunciate dallo speaker pubblicamente.

Tutti i cavalli qualificati per il campionato dovranno prendere parte alla competizione.

Un certificato veterinario redatto dal veterinario della Dc potrà giustificare l'assenza di un cavallo al campionato. Senza il certificato del veterinario della Dc il cavallo verrà squalificato dallo show, cancellate le qualifiche ottenute e squalificato dalle competizioni per un anno dalla data dello show. In questo caso il cavallo qualificato dietro al cavallo eliminato guadagnerà un punto in classifica ma non potrà accedere al campionato.

## METHODS AND RULES OF JUDGING CHAMPIONSHIPS OPEN ECAHO METHOD

The Gold, Silver and Bronze medal winners will be selected from amongst all the horses which have qualified in their respective classes for each championship.

The number of horses qualified from each class will be officially announced by the show organizer in the schedule and the show catalogue. The Championships will be judged as follows: All the horses qualified for the championship will enter the ring and line up according to the numerical order of their catalogue numbers. The horses will be judged individually, standing and trotting. Each judge will nominate his choice for gold silver and bronze medals together at the same time, from amongst all the horses qualified for the championship.

Points will be given to the nominated horses as follows

- A horse nominated by a judge for Gold Medal will receive 4 points.
- A horse nominated by a judge for Silver Medal will receive 2 points.
- A horse nominated by a judge for Bronze Medal will receive 1 point.

**The Gold Medal will be awarded to the horse with the most votes for Gold Medal Champion.** In case of an equal amount of vote for Gold Medal Champion, the Gold Medal will be awarded to the horse with the highest number of championships points.

From the remaining horses: The Silver Medal will be awarded to the horse with the highest number of championship points.

The Bronze Medal will be awarded to the horse with the 2nd highest number of championship points. In case of a tie in the championships, the higher place will be given to the horse with the highest total points in the qualifying classes. If the highest and lowest points are eliminated, only the remaining points for total, type and movement are considered in the tie break. If there is still a tie, the rules for ties in qualifying places will be applied. The judges will not discuss the horses. A fourth horse will be selected, which will become the Bronze medal winner should one of the three medal winners be disqualified. If this exhibit is not apparent from the voting papers, the judges will be asked to nominate one. This horse will not be announced. In the event that two or more of the medal winners are disqualified, no further substitution will be made. All horses that qualify for their respective Championships must take part in the Championship. Unless a certificate from the DC veterinarian is produced, failure to compete will disqualify the horse from the show, with its record of score and class placing being deleted and the horse being disqualified from showing for the period of one year as from the date of the show. In the event of a disqualification, horses placed behind the disqualified horse will move up a place in the class. Should a horse be sent out of the ring by the judges or taken out by the handler for any reason, it will be deemed to have taken part in the championship. All horses that are awarded a medal in their respective Championships must take part in the Championship prize giving ceremony. Unless the DC decides otherwise in which case any representative of the horse may accept the medal without the horse being present, absence of the horse or any representative to appear in the prizegiving ceremony will disqualify the horse from the show with its record of score in the class and championship placing being deleted and the horse being disqualified from the showing for the period of one year from the date of the show. In the event of a disqualification, all horses placed behind the disqualified horse will move up one place in the Championship.

## FUTURITY INFORMAZIONI GENERALI

Le categorie futurity non fanno parte del campionato e sono aperte a tutti i puledri nati nel 2022 che abbiano compiuto 4 settimane di età alla data dello show, la cui domanda di registrazione sia stata regolarmente trasmessa all'ANICA, completa di tariffa di registrazione, entro il termine di iscrizione del concorso.

Le categorie futurity sono riconosciute dalla EAHSC e devono seguire il seguente regolamento:

a) I puledri non possono competere nel campionato EAHSC, né possono beneficiare di alcun titolo e nessun qualifica di show per classe A.

b) nelle classi futurity che si svolgeranno durante una manifestazione affiliata EAHSC, il regolamento

EAHSC verrà applicato.

c) Tutti i puledri devono avere un'età di 4 settimane alla data di presentazione, e devono essere accompagnati dalla mamma in campo fino all'età di sei mesi.

d) E' vietato l'utilizzo, per i puledri dell'anno, di capezzine con metallo e con catene.

e) E' possibile tosare il corpo o parti di esso (es. tosatura parziale della testa e del collo) tranne nella zona intorno agli occhi e al muso. Compreso esportazione con metodo epilatorio e depilatorio dei peli tattili.

f) I puledri devono essere tenuti alla mano durante la cerimonia di premiazione.

I futurity, per partecipare allo show dovranno essere in possesso del microchip e del passaporto, o qualora non disponibile, della copia della documentazione inviata ad ANICA (Modello II) per la registrazione del puledro con relativa fotocopia del CIF, del modulo denuncia di nascita con descrizione grafica del soggetto e pagamenti effettuati per la registrazione, e deve essere accompagnato/a dalla madre naturale o embryo transfer fino ai 6 mesi di vita.

## **FUTURITY GENERAL INFORMATION**

Foal Classes In those shows where foal classes are held:

a) Foals may not compete in EAHSC Championships, nor will they qualify for any future Title or A Show.

b) When foal classes are organized at EAHSC affiliated shows, the EAHSC Rules will apply.

c) Foals must have a minimum age of four weeks at the date of the show, and must be shown at foot (with the dam) up to 6 months of age. Orphaned or rejected foals under six months may not be shown.

d) The use of metal halters and halters with metal chains is forbidden.

e) It is possible to shear the body or parts of it (e.g. partial shearing of the head and neck) except in the area around the eyes and muzzle. Including export with epilatory and depilatory method of tactile hair.

f) Foals must be hand held during the awards ceremony

Futurities, to participate in the show, must be in possession of the microchip and passport, or if not available, the copy of the documentation sent to ANICA (Model II) for the registration of the foal with relative photocopy of the CIF, of the birth report form with graphic description of the subject and payments made for registration, and must be accompanied by the birth mother or embryo transfer up to 6 months of life.

## **METODO DI GIUDIZIO**

Il metodo di giudizio per le categorie futurity è il metodo per comparazione. Ogni giudice stilerà individualmente la propria classifica dal primo al terzo o quinto classificato (in base al numero di cavalli iscritti). La segreteria assegnerà poi ad ogni singola classifica: 10 punti al primo, • 6 punti al secondo, • 4 punti al terzo, • 2 punti al quarto, • 1 punto al quinto. La classifica finale è data dalla somma della classifica finale di ogni singolo giudice. Verranno premiati i primi tre classificati di ogni categoria. in caso di parità uno dei giudici, estratto a sorte, scioglierà con la sua scelta l'eventuale ex aequo.

## **JUDGMENT METHOD**

The method of judgment for futurity categories is the method for comparison. Each judge will individually draw up his own ranking from first to third or fifth classified (based on the number of horses entered). The secretariat will then assign to each individual ranking: 10 points on the first, • 6 points on the second, • 4 points on the third, • 2 points on the fourth, • 1 point on the fifth. The final ranking is given by the sum of the final ranking of each individual judge. The first three classified in each category will be awarded. in the event of a tie, one of the judges, drawn by lot, will dissolve any ex aequo with his choice

## **PROVVEDIMENTI DISCIPLINARI**

In caso di comportamenti scorretti o abusi sui cavalli, verranno applicati i seguenti provvedimenti disciplinari a discrezione del giudice di campo, della Commissione Disciplinare o show officials (art. 16 e 17 del Blue Book 2021) art . 16:

a) cartellini gialli e rossi possono essere visualizzati come un avvertimento immediato , visibile e pubblica di un reato essendo stato commesso .Quando a seguito di un'indagine della DC è convinta che una persona abbia commesso un infrazione, essa ha il potere , a sua discrezione di imporre uno o più dei seguenti sanzioni o misure : b) Un avvertimento verbale ; c) richiamo scritto; d ) Una multa non superiore a € 300 - o l'equivalente nella valuta locale ; e) squalifica del cavallo ;f) Sospensione della persona responsabile e tutti i suoi cavalli di prendere parte allo spettacolo attuale g ) L' espulsione; h ) Il divieto del showground e/o le stalle e/o altri rispettive sedi ;

E 'responsabilità della Dc per trasferire qualsiasi inflitta al conto bancario del ECAHO (costi di trasferimento devono essere pagati da ECAHO).art . 17: Quando nel parere della DC qualche multa o sanzione superiori a quelli consentiti loro dalla Regola 16, di cui sopra dovrebbe essere inflitta , segnalerà la questione al DSC

## **PENALTIES AND MEASURES**

16. a) Red and Yellow Cards may be shown as an immediate, visible and public warning of an offence having been committed. When as a result of an investigation the DC is satisfied that any person has committed an infringement, it has the power at its discretion to impose any one or more of the following penalties or measures: b) A verbal warning; c) A written warning; d) A fine not exceeding €300.- or its equivalent in local currency; e) Disqualification of the horse; f) Suspension of the person responsible and all his horses from taking part in the current show. g) Spare; h) A ban from the showground and/or the stables and/or other respective premises for a period of two months; i) Any equipment intended to alter the natural appearance of the horse, and any equipment being used to inflict pain, intimidation or noise may be confiscated. If a fine is imposed by a DC, this must be paid by the implicated party or the horse cannot be shown. If the fine is imposed after the horse has been shown and it is not paid, the horse will be disqualified. If the fine is not paid before the end of the show it must be received in full by ECAHO before that horse or any other horse owned by the person responsible, stud farm or breeding entity concerned can be shown in an ECAHO affiliated show. Should the horse /horses be sold to another person/stud farm/breeding entity, the amount of the fine must be received in full by ECAHO before the horse/horses can be shown in an ECAHO affiliated show. It is the responsibility of the DC to transfer any imposed fine to the bank account of ECAHO (transfer costs to be paid by ECAHO). 17. When in the opinion of the DC some fine or penalty greater than those permitted to them by Rule 16 above ought to be imposed, it will report the matter to the SDC.

1. 3. I cavalli che sono in possesso di una certificazione che attesti le regolari vaccinazioni avvenute prima del 2009 non sono tenuti a soddisfare i requisiti del primo richiamo Booster, solo se in possesso di una certificazione che attesti che non ci sia stato alcun intervallo nelle vaccinazioni.
4. I successivi richiami Booster dovranno essere somministrati ogni 12 mesi o intervalli inferiori qualora le autorità locali o nazionali li richiedano. Tuttavia i cavalli che gareggiano devono essere stati vaccinati entro 6 mesi +21 mesi dall'arrivo allo show.
5. Nessuna vaccinazione può essere somministrata nei 7 giorni precedenti all'arrivo del cavallo alla sede dell'evento Ecaho.
6. I vaccini devono essere somministrati da un veterinario. Il nome del vaccino usato, la marca e il numero seriale del vaccino usato devono essere trascritti nel passaporto del cavallo, con timbro e firma del veterinario che ha praticato la vaccinazione.
7. 9. I recidivi di qualsiasi violazione del requisito minimo di vaccinazione saranno segnalati alla DSC per l'esame di sanzioni più elevate.

### **Equine Influenza vaccination for all horses competing in ECAHO competitions**

1. All horses (except foals at foot of the dam) must have received an initial Primary Course of two vaccination doses administered a minimum of 21 and a maximum of 92 days apart. Foals should begin the primary course of vaccination at 6

months of age. It is under the owners' responsibility if they are shown before the primary course of vaccination is complete.

2. The First Booster must be given within 7 calendar months following the date of administration of the second vaccination of the primary course. Horses which have received a correct primary course of vaccinations may arrive at an ECAHO event up to 6 months + 21 days months after the second dose of the primary course.

3. Horses that were correctly certified as receiving the primary course prior to 2009 are not required to fulfil the requirement of the first booster, providing there has been no lapse in their vaccination regime.

4. Further booster vaccinations must be given within 12 months of the last dose, or shorter intervals where local or national authorities require it. However, horses that are competing must have been vaccinated within 6 months +21 days of arriving at the Show an ECAHO event.

5. No vaccination may be given within 7 days of the day of arrival at the ECAHO event.

6. Vaccines must be administered by a veterinarian. The details of the vaccine, serial/batch number and the date of administration must be recorded in the passport, signed and stamped by the veterinarian who administered the vaccination.

7. The entering of vaccination details in a new passport or a duplicate: if the vaccination history of a horse is very long, the veterinarian may use the following statement "The vaccination history of this horse is correct to date .....(enter the last vaccination date)", signed and stamped by a veterinarian.

8. Sanctions for vaccination irregularities: a) regarding the 6 months + 21 days from last vaccination date: • Up to 1 week late: o a fine of €130. The horse will be allowed to compete. • Between 1 and 2 weeks late: o a fine of € 200. The horse will be allowed to compete. • More than 2 weeks late or - Last vaccination within the last 7 days of arrival: o a fine of € 280, the horse will not be allowed to compete and must leave the show ground as soon as possible. b) regarding incorrect, incomplete or missing Primary course, Incorrect or missing First booster vaccination and/or Overdue yearly booster: • where required: a fine of € 280, the horse will not be allowed to compete and must leave the show ground as soon as possible. (The vaccinations must be restarted as in articles 1 and 2).

9. Repeat offenders of any minimum vaccination requirement contravention will be reported to the SDC for consideration of higher sanctions.

By participating at a show, show organisers, judges, exhibitors, owners and handlers agree that they will unconditionally submit themselves and the persons assisting and accompanying them to the "Rules for Conduct of Shows" and, as regards veterinary matters and drug misuse, to the relevant ECAHO Veterinary Regulations and ECAHO Rules for Medication Control. The accompanying persons include e.g. trainers or persons representing the show organizer as well as assistants of any of those persons. They will accept the jurisdiction of the Disciplinary Committee (DC), the Standing Disciplinary Committee (SDC) and the ECAHO Appeals Committee (EAC). The person responsible for the horse is the

registered owner or the lessee, but the person who signs the entry form, the handler, and other support personnel including but not limited to grooms and veterinarians may be regarded as additional persons responsible if they are present at the event or have made a relevant decision about the horse. Should the person responsible designate someone to represent them (e.g. a lawyer) any correspondence sent to this representative will be deemed to have been communicated to the person responsible. These Rules will be interpreted when necessary under the provisions of the laws of Switzerland. Show organisers are not permitted to introduce rules which are in conflict with the EAHSC "Rules for Conduct of Shows".

2. Horses must be accompanied at the show by a horse passport containing all vaccination records. Those horses coming from a country that does not issue a passport, must be accompanied by an official Registration document which includes a graphic description and all vaccination records. If, when a horse attends a show, its passport is at the Registry for any reason, then a letter from the registrar attesting to this must be provided along with a photocopy of the passport, including the description and the vaccination records. The show organizer

3. The show organiser reserves the right to refuse an entry, but must give the reason for refusal in writing.

4. The show organizer will issue a printed show catalogue. The name of every horse must be printed in the show catalogue, as well as the names of sire and dam, (and maternal grandsire if possible), date of birth, colour, the names of the breeder and the owner. Should a horse's name not be mentioned in the catalogue, its participation at the show will be allowed only if the exhibitor cannot be blamed for the omission; it will be for the DC to decide. The show catalogue shall furthermore contain:

- The names of all the Officials,
- The Rules for Conduct of Shows the respective ECAHO generated QR Code,
- The Rules for Conduct of ECAHO Sport Competitions or the respective ECAHO generated QR Code if ECAHO affiliated Sport Classes are scheduled,
- The judging system (i.e. how many topics, 10 or 20 point system and whether halfpoints and deleting highest/lowest point system are used), the rules for ties and championships, the type of championship chosen by the organizer and rules for foal classes (if applicable)

For Shows where prize money is awarded the total amount and distribution of the prize money.

5. No class may be split unless there are more than 10 horses entered. Combination of a class with the next age group of the same sex is permitted if the number of entries for the class is below three.

6. a) No announcement indicating the identity, breeding or past performance of exhibits, or the identity of their owners will be made during judging. It is, however, permissible for this information to be given out after the judges score sheets have been collected for each exhibit. b) Show organisers will not release details of competitors or their exhibits to the press at any time prior to the European Arab Horse Show Commission Blue Book 2021 Rules for Conduct of Shows 29 catalogue being put on sale at the showground. Catalogues will not be offered for sale, published or posted on internet more than one day before the commencement of the show. c) If the same horses participate in multiple events on the same day or consecutive days at the same venue, the following restrictions apply for the judging of these events: ECAHO Affiliated Non amateur halter Amateur halter Sport Non amateur halter 2 1 1 Amateur halter 1 2 1 Sport 1 1 1 1 - Combination is allowed to be judged by the same judge(s) 2 - Combination is not allowed to be judged by the same judge(s). c) If two ECAHO affiliated In Hand shows (e.g. a B Int and a C Nat) are held at the same venue on the same or consecutive days, in which some of the same horses will be competing, two separate panels of judges must be invited, one panel for each show. The judges of the second event cannot be present at the showground during any part of the first event. This restriction does not include ECAHO Sports events, Amateur In Hand classes/shows or non-affiliated events. In these cases, the ECAHO In Hand show(s) must be judged before the others.

7. a) No member of the show organising team may judge, or officiate as member of the Disciplinary Committee. b) If an ECAHO Official or a member of their family is a part of the Organizing Committee of an independent A or Title show, which is not organized by the National Association of the country where the show is held, then that Official cannot officiate at any other A or Title shows. c) Members of the Organizing Committees of A and Title shows may not enter their own horses in a Show which they organize. d) No Judge may judge more than one Title Show within Europe and one Title show outside Europe during the same calendar year. e) No Judge may judge more than 15 Arabian horse halter shows in ECAHO Member countries in the calendar year. No Judge from non-ECAHO Member countries (Guest Judge) may judge more than five Arabian horse In Hand shows in ECAHO Member countries during the same calendar year; of the five shows, only one may be a Title Show and one an A Show. f) No Member of the DC / Ringmaster may officiate at more than 15 Arabian horse shows in ECAHO Member countries in the calendar year.

8. The show organizers will ensure a proper rotation of judges.

9. The show organiser will provide appropriate transport, accommodation and meals during the show, for the judges, DC members, ring master and any other ECAHO show officials. If a judge, DC member or ring master cancels the invitation after the travel



arrangements have been made, he will pay all the costs arising out of this booking. 10. The following minimum daily fees are mandatory and to be paid by the organizer to judges, DC members and ring masters per working day regardless of the actual hours: B International, C International, European and Specific Origin shows: € 100,- / A shows: € 150,- / Title shows: € 200,-. For all other shows a daily fee is optional and at the discretion of the show-organization. Material gifts are always allowed, regardless of the category of the show. Judges, DC Members, Ringmasters and respective probationers, hereafter referred to as 'Official(s)' 11. Officials invited to officiate at ECAHO affiliated shows agree to do so with integrity and honesty and to carry out their duties solely with the objects of ECAHO and the welfare of the horses in mind. European Arab Horse Show Commission Blue Book 2021 Rules for Conduct of Shows 30 12. a) Officials appointed at a show will not knowingly officiate in a class in which horses are entered concerning which there may be an actual or apparent conflict of interest. No official appointed at the show may exhibit, ride, drive or handle an entered horse or pursue any other activity not consistent with his duties at the show in which he is officiating. b) Exhibitors will declare on the entry form any actual or apparent conflict of interest with any of the officials invited for the show. Any exhibitor not declaring an existing conflict of interest, of which he is aware, will forfeit all entry fees and will be prevented from showing the horse. c) Organizers will not accept any entries for which any actual or apparent conflict of interest with one of the appointed officials has been indicated by the exhibitor, unless a reserve official is available. d) Officials will not visit exhibitors' premises or accept exhibitors' hospitality during a 30 day period before or during the show concerned. e) Officials will not accept benefits or gifts that could bring into question the Official's integrity or honesty. f) Any actual or apparent conflict of interest that arises before or during the show shall be immediately reported to the DC. The DC shall consult all parties involved and use all sources to their disposal to decide as necessary. The DC must include all information in their report and forward to ECAHO after the show. At no time may the organizer take any decision that is in conflict with the jurisdiction of ECAHO and its' rules and regulations. g) Any actual or apparent conflict of interest that arises after the show shall be reported immediately to ECAHO for consideration by the SDC. 13. a) An actual or apparent conflict of interest may occur if a horse is exhibited that:

- Is being trained or handled by a member of the official's family
- has been bought or sold by an official either as owner or agent
- has been bred or is owned in whole or part by the official or by a member of the official's family, or business partner in an Arab horse business venture
- has been leased by the official, at any time
- has been bred by or is the property of a breeding organization in which the official is or was an employee
- has been regularly trained, examined or treated by the official in a professional capacity
- is the subject of an on-going negotiation to buy or lease, or a provisional purchase condition to which the official is a party.

An actual or apparent conflict of interest may further occur, amongst others, if the Official, irrespective of the payment or receipt of a remuneration or any other consideration, during the period of one year (365 days) before a show at which the Official officiates:

- has entered into any business relationship with an exhibitor at that show,
- Has received, whilst being involved with the organization of any show or event, sponsorship from an exhibitor at that show or event. This does not apply to those events organized on behalf of a National Association which is a Full Member of ECAHO, as long as the Official has no financial benefit from the sponsorship.
- has performed consulting for an exhibitor at that show,
- has purchased or sold a horse from or to an exhibitor at that show,
- was involved with the breeding of a horse of an exhibitor at that show,
- was involved in similar activities with an exhibitor at that show.
- is employed in any way by the Show organizers.

In case of doubt, the DC's decision will prevail. Any Official must decline to officiate if they consider themselves to have a conflict of interests concerning a horse, its' handler or its' owner(s). 13. b) If, during the show a conflict of interests of which the exhibitor was un-aware becomes apparent, the following options are available: i) if the official with the conflict of interests is a judge or probationer judge, European Arab Horse Show Commission Blue Book 2021 Rules for Conduct of Shows 31

- the judge or probationer judge will suspend his/her duties for the duration of the class and the championship where the conflict exists
- a published reserve judge or another judge from the judges' panel may be used for the class and the championship where the conflict exists
- if the above mentioned (i) is not applicable and if no reserve judge is available or there are no more members of the judges' panel, the total points in the class will be multiplied by the factor of planned number of judges divided by the actual number of judges, to calculate a comparable score in case of ties in championships

ii) if the official with the conflict of interests is a DC member, this DC member will not check the horses concerned either in the stables before the show or in the collecting ring. If the DC member is an employee of the Show Organizer, this DC member must not write the DC Report. Another member of the DC who has no connection to the Show Organizers will write the Report. iii) if the official with the conflict of interests is a

Ringmaster, this Ringmaster may be replaced for the duration of the conflict by: • a reserve Ringmaster • a member of the acting DC All aspects concerning actual conflicts of interests and their consequences will be recorded in the DC report. 14. All officials will receive a list of exhibitors and sponsors from the organizer immediately after the official closing date of entries. Any later entries will be communicated without delay. Judges will not consult the show catalogue before or during the show at which they are judging. 15. In the show ring, all communication between judges and handlers prior to the presentation of prizes will be through the Ringmaster. 16. Judges may withhold any award if in their opinion the exhibit does not merit such an award. 17. The judge, or if more than one, the panel of judges may request that the ring master show a handler a yellow or red card if they consider that there is abuse to a horse or that there is misconduct. Conduct of Halter Classes 18. All handlers at A and Title Shows must be in possession of a valid handlers permit which they must present to the DC in order to participate in the Show. 19. Handlers will be neatly dressed. They may wear any costume normally worn in their country of origin. Handlers will not wear clothes carrying any form of advertising which discloses the connection of the horse they are handling. 20. The judge(s) may request that the ringmaster order any horse that is not under control and/or displays dangerous behaviours to be withdrawn and the horse shall be disqualified. 21. The judge(s) may request that the ringmaster ask a handler to open a horse's mouth or pick up its feet for inspection. 22. Exhibits are to be judged standing, walking and trotting. No more than three circles will be permitted in each individual presentation. Handlers who do not comply with the ring master's instructions regarding the above may be given a Yellow/Red card by the ring master. European Arab Horse Show Commission Blue Book 2021 Rules for Conduct of Shows 32 23. a) Horses will appear in the collecting ring no less than 10 minutes before the start of the class. b) Exhibits that appear late (missing the walk around the ring) will be excluded from the class. 24. a) Stallions and colts aged three years and over may be shown wearing bridles and bits that are both secure and comfortable for the horse. All bridles without bits are equally to be both secure and comfortable for the horse. Any horse that is not under control and/or displays dangerous behaviour anywhere on the showground will be disqualified. b) The lead reins for all horses must be no longer than 3 m. 25. a) Any horse becoming loose in the collecting ring is subject to a penalty (of a fine not exceeding 100 €) at the discretion of the DC. b) Any horse becoming loose in the show ring will immediately continue to be shown and is subject to a penalty (of a fine not exceeding 100€) at the discretion of the DC. Should the horse become loose a second time it will be disqualified. 26. All horses that are awarded a ranking in their respective class must take part in the Class prize giving ceremony. Unless the DC decides otherwise in which case any representative of the horse may accept the medal without the horse being present. Absence of the horse or any representative to appear in the prize giving ceremony will disqualify the horse from the show, with its record of score in the Class being deleted and it will be sanctioned according to Rules for Disciplinary Committees article 16. In the event of a disqualification, all horses placed behind the disqualified horse will move up one place in the Class ranking. Soundness 27. Exhibits that appear to be lame may be assessed and placed by the judges. Judges may exclude any horse so lame that assessment will inflict pain. Rules for adapting score sheets 28. Judges may record their scores using paper score sheets or electronic devices. If paper score sheets are used, organizers are expected to provide scoresheets with pre-printed score-options which judges can circle to indicate their scores. Judges are not allowed to write scores. Electronic devices, for example tablet systems, may be used but can be subject to audit by ECAHO appointed experts to confirm proper functionality and logging at any time. Regardless of the scoring system used, once the judge has submitted a score, either by handing off a scoresheet or by sending the data from an electronic device, the Judge cannot amend or change the score. Only technical omissions such as missing scores and/or missing signatures may be corrected upon request of the scorekeeper. Disguising of Exhibits 29. No alteration of the basic colour of the skin, coat or hooves is permitted. Hoof paints, colourless varnishes, coat dyes, glitter spray and cosmetic operations including skin grafts are forbidden. Tail and mane hair extensions are forbidden. Colourless hoof oils, Vaseline or oil and white chalk used on white legs will be accepted. 30. Artificial methods of dilating the eyes or affecting the natural action of the horse or otherwise influencing its action or behaviour by oxygenating the bloodstream or by the use of weights or artificially weighted shoes, or by electrical or chemical treatment of any kind at any time before or during exhibition are forbidden. Burns, cuts or other marks on the body of any exhibit in such places or positions as to indicate that prohibited methods have been used will be regarded as full and adequate grounds for exclusion of any exhibit from competition, at the discretion of the DC with veterinary advice. European Arab Horse Show Commission Blue Book 2021 Rules for Conduct of Shows 33 31. a) In halter classes horses may be fully or partly body-clipped, subject to eyelashes being left uncut, hair inside the ears left unshaved and tactile

hair left intact around the nose, muzzle and the eyes. Horses not fulfilling these criteria will not be allowed to participate. "Balding" is not encouraged. b) No equipment intended to alter the natural appearance of the horse is permitted in the stables, including but not limited to necksweats, neck collars, tailracks, hobbles or weights. Anyone using such equipment on the showground will be sanctioned according to Rules for Disciplinary Committees article 16. 32. spare Cruelty 33. Excessive whipping, excessive stimulation by noise, excessive circling of the horse, intimidation, use of electric shock devices and infliction of pain by any means are forbidden in all parts of the showground or stable areas, at all times. Abusive shanking is not permitted. 34. The above actions will be sanctioned. Enforcement 35. Verbal warnings: DC members, ringmasters, stewards or show officials may issue verbal warnings. These are not recorded in the DC report. 36. Yellow and red cards may be issued by DCs and Ringmaster in the collecting ring and the main ring. They are issued to a handler and are a visible and public indication of an offence having been committed. The date and offence will be recorded in the DC report and must be made public by announcement at the show and/or on the ECAHO website and/or other usual means of communication of ECAHO. 37. A yellow Card may be issued if there is a further offence after a warning or it may be issued without such warning. 38. A red Card will be issued if the handler receives a second yellow card for having committed a further handling offense during the same show. The offender will then be banned from handling any horses for the rest of the show in which he receives the red card. The horse being shown by a handler when he receives a red card may be shown by another handler at the end of the class. In the event of a serious offence involving mistreatment or dangerous behaviour, DCs may issue a red card without prior warning. 39. a) Any handler disobeying the instructions of any DC member, judge or the ringmaster will be sanctioned. Such sanction can be visibly and publicly indicated with yellow and red cards. b) Any handler who receives two yellow cards or a direct red card at a show will be fined 1000€. c) Any handler who accumulates five yellow cards at different shows during the calendar year will receive a fine of 1000€ In both cases the fine must be received in full by ECAHO before handler can present horses again in any ECAHO affiliated show. Veterinary Matters 40. Horses with apparent clinical signs of a disease may not participate at the show at the discretion of the DC Veterinarian. If the DC Veterinarian diagnoses apparent clinical signs of a contagious disease, the horse must be immediately put into quarantine and may not participate at the show. 41. Vaccination regulations for shows will require 12 months intervals normally, or shorter where local/national authorities mandate it. Such shorter intervals to be shown on the entry form (see Addendum – Equine Influenza Vaccination page 59). 42. All Veterinary treatment necessary at the show ground must be carried out according to ECAHO Veterinary regulations. The person responsible for the horse will ask the vet who treats the horse to complete a treatment European Arab Horse Show Commission Blue Book 2021 Rules for Conduct of Shows 34 form and present it to the DC-vet at the show. Any treatment given to a horse immediately prior to a show should be recorded on a treatment form by the treating vet and presented to the DC upon arrival at the show. 43. a) The administration of any substance not a normal nutrient (including irritants applied to the skin or mucous membranes or mydriatic drugs in the eyes), whether intentionally or unintentionally which may affect the performance, temperament or soundness of an exhibit is forbidden. b) The DC may order chemical tests on any exhibit. c) Judges may request the DC to test any horse. (See the section on "Medication Control" page 47). Complaints 44. A show organiser, appointed judge, ring master, exhibitor, owner or handler of a horse entered at the show may lodge a complaint alleging infringement of the rules of the EAHSC, contained in the "Blue Book". Any complaint, except concerning a complaint about a judge or any other official including show organisers, is to be made in writing before the end of the show. A deposit of € 200,- or equivalent in local currency will be lodged with the DC and may be retained at the DCs discretion, if the complaint is considered frivolous. Such forfeiture belongs to ECAHO. 45. Any complaint about a judge or any other official including the show organisers is to be made in writing and signed by two individuals. Such complaint must contain any evidence and be sent to the ECAHO executive Secretary with full name and postal address of the complainant within 3 days of the show. A deposit of € 300 must be paid in accordance with the instructions and deadline given by the Executive Secretary. The investigation of the complaint will be conducted in accordance with the Rules for Disciplinary Committees, articles 19 et seq.
